Basic rules for disposal of recyclables and waste

O Please take out recyclables and waste by 8.30am.

- O Items longer than 30 cm on any side are classified as 'oversized waste'.
- O Do not take out on days other than the collection day or after collection.

Unburnable waste

- Glasses and ceramics: tea bowls, plates, cups, flowerpots, flower vases, mirrors, cosmetic bottles, ashtrays, etc.
- ◆ Small electrical goods: irons, flashlights, cameras, etc.
- Household goods: CDs and DVDs (including cases), kitchen knives, razors, Tupperware, disposable lighters, etc.
- Cassette gas cylinders: cassette gas cylinders, spray cans, etc.
- ◆ Stationery: compasses, rulers, ball-point pens, etc.
- ♦ Others: toys, aluminum foil, incandescent and LED bulbs, etc.
- ♦ Items that can be taken out even if they are over 30 cm long on any side: umbrellas, one-handed pans, frying pans, iron hangers, etc.

Once a month on the (1,2,3,4) ()day % Collected even on public holidays

- ◆ Use designated orange waste bags.
- ♦ Wrap dangerous items such as knives or broken glass in paper or similar.
- Use up cassette gas cylinders and spray cans. Make a hole in the cylinder and release the gas before taking it out.
- Please use up the contents of lighters before taking them out.
