

# How to sort and take out recyclables and waste




## Basic rules for disposal of recyclables and waste

- Please take out recyclables and waste by 8.30am.
- Items longer than 30 cm on any side are classified as 'oversized waste'.
- Do not take out on days other than the collection day or after collection.

## Type of Waste

## How to take out waste

### Burnable waste

- ◆ Kitchen waste: food skins and bones, leftovers, eggshells, shells, refrigerants, solid oil, etc. 
- ◆ Paper and fabrics: diapers, receipts, paper cartons (less than 1000 ml), boxes of detergent, underwear, socks, stuffed animals, rubber gloves, etc. 
- ◆ Leather goods: bags, shoes, sandals, belts, slippers, etc. 
- ◆ Wooden products: building blocks, pencils, disposable chopsticks, etc.
- ◆ Plants and trees : See Exceptions ②、③ below

※ Collected even on public holidays

- ◆ Use pink waste bags designated by Yotukaido City
- ◇ To reduce the amount of food waste, please help us with the following two points.
  - ① Reduce food losses.
  - ② Completely drain kitchen waste
- ◆ Recyclable paper such as empty boxes of snacks and other items should be disposed of as resources.



### Burnable waste that you can dispose of using other than designated waste bags(pink)

#### Exception ①

- Paper diapers (excluding for pets).  
You can also use see-through bags (50 liters or less).
- ※ Flush the droppings of the diaper in the toilet.
  - ※ For hygiene reasons, using a double layered bag is recommended.



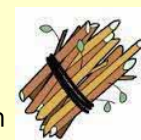
#### Exception ②

- Grass, leaves, twigs, and stems.  
You can also use see-through bags (50 liters or less).



#### Exception ③


- Pruned branches, etc.  
Cut pruned branches etc. to less than 5 cm thick and 50 cm long and bundle them to the diameter of 30cm or less and tie them with cord.
- ※ Branches between 6 cm and 15 cm thick and between 51 cm and 150 cm long are 'oversized waste'.
  - ※ Remove leaves from the pruned branches









### Plastics and vinyl

- ◆ Plastic bags: snack bags, plastic shopping bags, etc.
  - ◆ Packages: egg cartons, packages for natto, dessert cups, etc.
  - ◆ Containers: lunchbox containers, instant food containers, detergent containers, etc.
  - ◆ Others: Styrofoam, cushioning materials, food trays, food wraps, films, vinyl gloves, caps and labels for containers, etc.
  - ◆ Plastic products: tooth brushes, straws, combs, buckets, Tupper wears, hangers, etc.
- ※From October 2024, some of the plastic products will be collected as "plastics and vinyls".


Once a week on ( ) day of the week  
※ Collected even on public holidays

- ◇ Use clear or translucent plastic bags. ※Don't use any designated waste bags including former yellow ones and from other cities.
- ◇ Plastics can be recycled. For better recycling quality, rinse plastic items to remove dirt before disposing. ※If the item is still very dirty after rinsing with water, dispose of it as burnable waste.
- ◇ Items with  sign on.
  - ※ Some products do not have this mark.
- ◇ Products that can be recycled as plastic are limited to those from plastic and do not contain metals, dry batteries, or rechargeable batteries.




◆ Bottles: bottles for foods, drinks and seasonings. (Liquor, jam, juice, nutritional drinks, baby food, cooking oil, vinegar, Chinese seasonings, etc.). 	◆ Cans(steel cans, aluminum cans) Cans for foods and drinks (Tea, juice, liquor, sweets, coffee beans, powdered milk, fruit, etc.) Pet food, metal caps of bottles, etc. 	◆ <u>Rinse the inside and place cans and bottles in an installed container at your designated collection point.</u> ◇ Crush cans as much as possible. ◇ Bottles of pharmaceuticals, cosmetics, sprays, paints, mosquito coil cans, etc. are 'unburnable waste'. ◇ Large bottles, cans of 18L or more, drum cans, etc. are 'oversized waste'. ◆ PET bottles: those marked 'PET1' 		◆ <u>Rinse the inside and place into the orange net bag at your designated collection point</u> ◇ Remove the caps and labels from pet bottles and squash them as flat as possible before disposing. <u>The caps and labels are 'plastics and vinyl'.</u>		
◆ Used paper for recycling: newspapers (newspapers, inserted flyers, etc.) :Magazines (books, catalogues, weekly magazines, copy paper, cardboard, etc.) :Corrugated board (corrugated board with core) :Paper cartons (for food or drink, e.g. milk, 1000 mL). :Miscellaneous paper (snack boxes, paper bags, wrapping paper, notepaper. Calendars ※excluding fittings, toilet paper cores, etc.)		◆ <u>Sort the items by type and tie them together with string both crosswise and lengthwise.</u> <u>Small miscellaneous papers should be directly put into 'the green mesh bag' at your collection point</u> ◇ Paper cartons less than 1,000 mL and waterproof are 'burnable waste'. ◇ Underwear, mats (30 cm or less on any side), old cloth (cotton or vinyl) are not fabrics but 'burnable waste'. ◇ Carpets, mats (30 cm or more on any side), lace curtains, bedding (e.g. blankets) are not fabrics but 'oversized waste'. ◇ Do not put out papers and fabrics on rainy days in order to maintain the quality for recyclables.		
◆ Fabrics: old clothes, sweaters, bed sheets, towels, curtains, etc. (excluding lace curtains)				
◆Used cooking oil: corn oil, sesame oil, rice oil, rapeseed oil, sunflower oil, salad oil, etc. 		◇ Dispose of used cooking oil according to the following procedure. (1) Cool the oil and remove the residues from it (2) Transfer it to a plastic bottle of visible inside and close the lid (3) Put it in a blue container in upright position. ◆ Animal oil such as butter, margarine, lard, etc. and machine oil such as engine oil are unable to be collected. ◇ Only used cooking oil or expired cooking oil is collected.		

Unburnable waste		Once a month on the (1,2,3,4) ( )day ※ Collected even on public holidays		
◆ Glasses and ceramics: tea bowls, plates, cups, flowerpots, flower vases, mirrors, cosmetic bottles, ashtrays, etc. ◆ Small electrical goods: irons, flashlights, cameras, etc. ◆ Household goods: CDs and DVDs (including cases), kitchen knives, razors, Tupperware, disposable lighters, etc. ◆ Cassette gas cylinders: cassette gas cylinders, spray cans, etc. ◆ Stationery: compasses, rulers, ball-point pens, etc. ◆ Others: toys, aluminum foil, incandescent and LED bulbs, etc. ◆ Items that can be taken out even if they are over 30 cm long on any side: umbrellas, one-handed pans, frying pans, iron hangers, etc.		◆ <u>Use designated orange waste bags.</u> ◇ Wrap dangerous items such as knives or broken glass in paper or similar. ◇ Use up cassette gas cylinders and spray cans. Make a hole in the cylinder and release the gas before taking it out. ◇ Please use up the contents of lighters before taking them out.

<b>Points to note</b>	<p>Check the signboards (A,B,C,D) at the waste collection points to see the type of waste and collection days.</p> <p>※In case the collection day for hazardous waste is a public holiday, the day indicated in parentheses ( ) is the collection day. (e.g. [1st (3rd) Monday] ⇒ When the 1st Monday is a public holiday, the 3rd Monday is the collection day).</p> <p>※Non-hazardous waste (burnable waste, plastic and vinyl waste, unburnable waste and recyclables) is collected even on public holidays. Excluding the New Year's Holiday.</p>

Items	Refrigerators and freezers, washing machines, clothes dryers, televisions, and air conditioners				
<div>◇ When buying (or replacing) an item</div> <div>Ask the store where you buy(replace) the item.</div> <div>Please buy a recycling ticket and complete the collection procedure at the store where you bought (or replaced) the item.</div> <div>◇ When <b>not buying (or replacing) an item</b></div> <div>Please buy a recycling ticket at a post office and bring it to a 'designated pick-up point' in person or ask Licensed General Waste Management Operators to collect the item.</div>
